## PROPOSED REZONING: PORTION 7 OF THE FARM BRAKKLOOF NR.443, AIRPORT ROAD FOR THE PURPOSES OF A PRIVATE SCHOOL (RAPHAELI WALDORF SCHOOL), BITOU MUNICIPALITY

The Manager: Land Use Management made the following decision on 1 November 2023 in terms of Section 60 of the Bitou Land Use Planning Bylaw:

That the following be approved:

- (1) The Rezoning of Portion 7 of the Farm Brakkloof Nr.443 from Agricultural Zone I to Institutional Zone I.
- (2) The above decision is subject to the following conditions in terms of Section 66 of the Bitou Land Use Planning Bylaw:
  - 1. That all the existing buildings in good condition be accommodated in the layout plan.
  - 2. That development occurs broadly in accordance with the SDP prepared by Marike Vreken Urban and Environmental Planners dated 2019 (SDP5), but that the access configuration be amended to reflect the approved access dated 22 February 2022.
  - 3. The conditions of the Environmental Approval dated 3 March 2020 must be adhered to.
  - 4. That the conditions of approval from WC Transport and Public Works dated 22 February 2022, be adhered to.
  - 5. That a refuse collection and storage area be constructed at the entrance to the development and be approved the relevant Section of the Municipality.
  - 6. The existing septic tanks need to be cleaned up and abandoned.
  - 7. That municipal services be provided at the cost of the applicant to the satisfaction of the Municipality, and that a Services Level Agreement based on the provisional Services Report (as well as any other requirements of the Municipality) be entered into, and that the payment of augmentation levies and capital contributions in accordance with the policy of the Municipality be stipulated in the Services Agreement (inclusive of performance of payment);

## **Appeals:**
