PURPOSE OF THE REPORT

For Council to take cognizance and approve the handover of construction of Ebenezer Top Structures to the Western Cape Provincial Department of Human Settlements

BACKGROUND / DISCUSSION

The Municipality has received the following allocations in this financial year, 2021/22 for the Construction of Engineering Services, SCM/2020/45/ENG in Ebenezer Portion 20:

SCM/2020/45/ENG commenced on 26 January 2021 and the anticipated due completion date is 05 May 2022, the contractor on site is SC Housing and consultants is Zutari formerly known as Aurecon. In order for the top structures to be constructed, the following outstanding planning and applications need to be in place:

- (a) General Plan has not been finalized due, the proposed General Plan is to be submitted to the Surveyor General for approval
- (b) Site Development Plan indicating exact houses locations
- (c) Master House Plans
- (d) Geotechnical Phase 2 Report
- (e) Structural Engineer Plan
- (f) Approved Town Planning Layouts

(g) Beneficiary list, screening and approval

The above list of outstanding applications and plans that could not be concluded timeously are as a result of Chauke Quantity Surveyors contract that was terminated due to varying interpretations with regards to contract ending period. It is assumed that the above processes can be concluded in a period of fifteen months from the date of commencement with the exception that the Provincial Government may assist with fast tracking the approvals.

FINANCIAL IMPLICATION

An allocation of about R39 860 000.00 (VAT Excl.) has been available to the Municipality and the breakdown of the allocation is as follows:

An allocation of about R15,260,000.00 (VAT Excl.) will be made available in the next financial year, 2022/23 to the Municipality as per the attached letter, Annexure A, "2022/23 Municipal Budget Allocations." The Municipality does not intend to have a counter top up funding budgeted for the construction of Ebenezer Top Structures.

In order for the Municipality to fast track the planning and implementation of all the outstanding plans and approvals with regards to Ebenezer and other planned housing projects, an outstanding payment of R1,734,081.01 (VAT Excl.) and the amount is also not taking into consideration the interest account submitted by Sonqua Consulting as a result of non-payment of Chauke Quantity Surveyors.

EXECUTIVE SUMMARY

The termination of the Chauke Quantity Surveyors contract without having in place at the time a Service Provider that could continue with the planning and implementation negatively impacted the delivery of planned housing projects in all Bitou Municipal areas. The housing backlog is putting more strain to the Municipality, the said cancelation of the Chauke contract worsened the situation even more.

An allocation of about R15,260,000.00 (VAT Excl.) will be made available in the next financial year, 2022/23 to commence with first phase of about 102 top structures. In order for the project to

be considered ready for commencement of top structures, plans and statutory framework approvals such as Environmental Authorization, registration of General Plan with the Surveyor General, etc. Currently the Municipality does not have the capacity to implement the project itself due the following reasoning:

- (i) The Manager Integrated Human Settlements is under suspension and it cannot be determined when will the disciplinary processes will unfold, the unit though having an Acting Manager seconded only in March 2022, it is still much unstable
- (ii) The magnitude of the works to be carried by the Section with regards to the construction of the Ebenezer Top Structures would need a very stable environment, where possible only one Project Manager must be assigned with the execution of the project rather than one commencing with the project and handing it over when the disciplinary processes are concluded
- (iii) The approved existing organogram of Integrated Human Settlements Section makes no provision for the execution of projects of this magnitude, it is for this reason that the Section has over relied on services of Consulting Engineers






