The Speaker called for nominations for the elections of the Executive Mayor.

It was proposed by Councillor T Mhlana and seconded by Councillor S A Mangxaba that Councillor C N J Terblanche be elected as the Executive Mayor. Councillor C N-J Terblanche signed the applicable nomination form in acceptance of the same.

A second proposal was received from Councillor W J Nel and seconded by N Ndayi that Councillor D J Swart be elected as the Executive Mayor. Councillor D J Swart signed the applicable nomination form in acceptance of the same.

The Manager: Legal Services, Mr Alan Crutts, explained the voting process. He pointed out and explained that voting will take place in terms of Schedule 3 of the Local Government Municipal Structures act (by secret ballot).

The Manager Legal Services further announced that Councillor Terblanche has accepted the nomination of Executive Mayor, and that he cannot further preside over the election. He explained that as a result, an acting Speaker needs to be elected in terms of Section 41 of the Local Government Municipal Structures act to preside over the election of the Executive Mayor.

Councillor C N-J Terblanche then announced that he is stepping down as Speaker.

It was proposed by Councillor S E Gcabayi and seconded by Councillor N P Kolwapi that Councillor T Mhlana be nominated as acting Speaker.

Councillor C N-J Terblanche then put the proposal of Councillor T Mhlana as acting Speaker to the vote by show of hands.

“Reassurance is the action of removing someone's doubts or fears. Community of Bitou, today I want to remove your doubts and fears and I would like to do so by reintroducing myself.

I am Claude Terblanche, I am a fiancé to my love Ardelia, I am a father, a son, a brother, a family man, a friend. I am Claude Terblanche a man committed to his community, a man passionate about equal opportunities, a man committed to the hopes, dreams, aspirations and needs of my beloved Plettenberg Bay, from the Garden of Eden to the beautiful village of Covie.

I am Claude Terblanche, a man committed to clean governance. For those who are fearful and doubtful, I am Claude whose objectives never changed from the moment I stepped in as Councillor and Speaker on 18 November 2021.

Today the faces of my partners have changed but my objectives and integrity will stay in tack. From today I will still remain the humble, hardworking and sport loving Claude, I will remain the same Claude who puts his community first, and I will remain the Same Claude who strives to outwork all of my fellow Ward Councillors in this Council Chamber today.

Service Delivery and a Budget that is inclusive of all wards to me is the backbone of why I was running for Council in 2021. Today on 2 February 2024, I still have the same reasoning.

Plettenberg Bay it's vital that this Council deliver services, it is vital for this Council to ensure a clean, safe, maintained and conducive environment. These services must be budgeted for all wards. From Harkerville to Covie, no community should be left behind.

The people of Bitou deserves a government that will prioritize a budget sufficient for the needs of all wards. The days of prejudice to certain wards are over. The days where certain wards are prioritized more than others are over.

I stand here today resolute in my reasoning and objectives.

IDP's are not meant to just remain a wish list and collect dust for 2-3 decades, the IDP should become a living document. The role of this council is to ensure that the IDP becomes a living document otherwise what are we here for? The IDP is the heartbeat of the people and the people should be the heartbeat of this council.

Issues such as write off augmentation and attracting development with the aim of job creation requires clear policy direction from Council.

Today many residents have fears. Fears of the unknown. But we want to assure the people of Plettenberg Bay that we are committed to do better than we have in the past two years.

We have appointed capable and competent senior management, and we rely on them to show maturity, professionalism, drive and commitment to this town and its people and for the administration to carry on with service delivery in the same way they have done since their appointment.

We will not slow down; in fact, we will accelerate and as the Executive Mayor of this town I expect faster turnaround times and even better responses to the needs of the people. I am Claude Terblanche; I am the Executive Mayor”.
