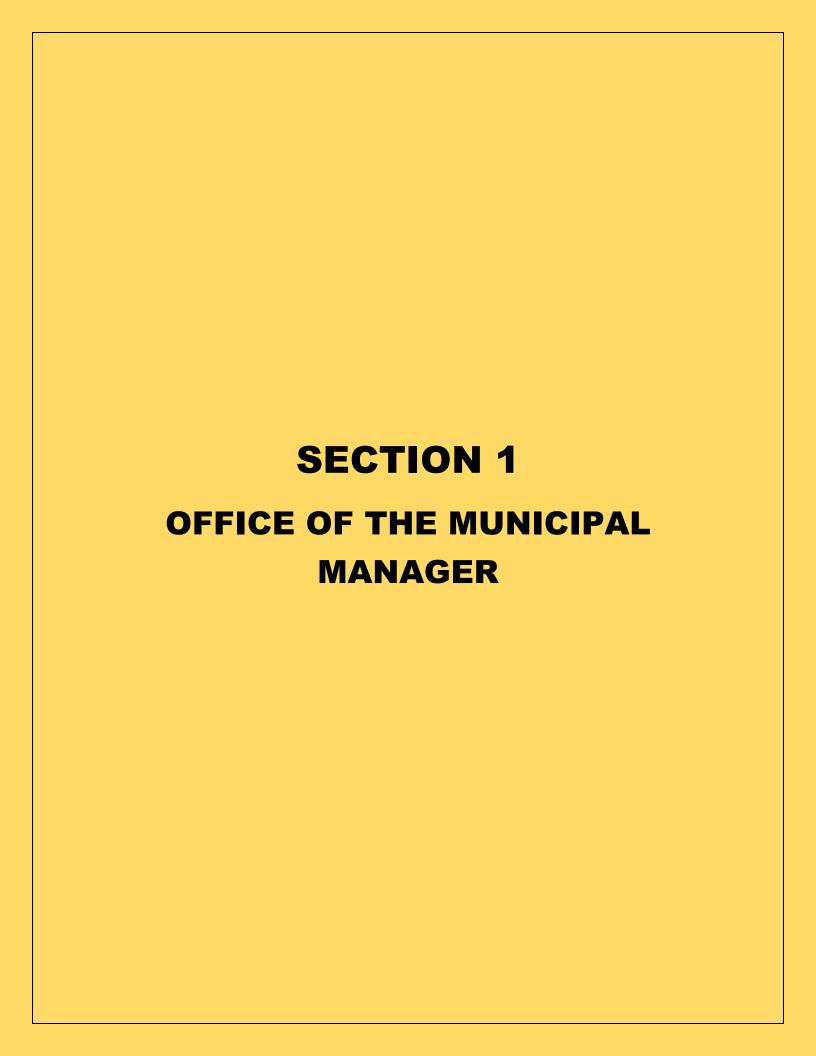

## PURPOSE OF THE REPORT

For Council to take further cognizance and or note further developments with the secondment from Central Karoo District Municipality (hereinafter referred as the "CKDM") of Dr. Ralph Links to act as Municipal Manager for a period of three (3) months ending 30 June 2024.

# **BACKGROUND**

At a Special Council Meeting held on 7 March 2024 Council took cognizance and /or noted the secondment from CKDM of Dr Ralph Links for a period of three (3) months ending 30 June 2024. See Resolution C/1/208/03/24. (Annexure A)

Council further noted that the Secondment Agreement entered and attached to the item contained material errors which had to corrected. Accordingly, the Secondment Agreement was corrected and re-submitted to CKDM for signature before it submitted to Council again.

The CKDM did not return the signed corrected Agreement submitted to them, but instead on 20 March 2024 advised the office of Executive Mayor, Cllr. Claude Terblanche, that Dr Ralph Links had resigned from their employment with effect from 31 March 2024 (Annexure B).

CKDM furnished the office of the Executive Mayor, with a copy of an extract of a minute of a Special Council meeting held on 1 March 2024 which confirms that Dr. Links resigned from their employment with effect from 31 March 2024 and that his resignation was accepted.

Accordingly, the secondment agreement and /or arrangement between the three parties terminates and /or will come to an end on 31 March 2024.


