

#### **PURPOSE OF THE REPORT**

To present a Grant in Aid allocation to the Mayoral committee for approval for the 2024/2025 financial year.

#### BACKGROUND/DISCUSSION

The municipality annually hosts Human Right Day and this year has decided to merge and give the opportunity for NGO's, NPO's and other welfare organisations to apply for grant in aid allocations in accordance with the grant in aid policy of the municipality. In accordance with the policy requirements, the Acting Chief Financial Officer convened a Grant in Aid Committee to consider the applications that were submitted.

The applications were firstly recorded in a register to ensure that all applications were accounted for vetted for compliance with the policy requirements and was further considered against the requirement of the advertisement that was placed.

A grant in aid committee was called to consider the submissions, it was found that all but one of the submissions requested general assistance through the grant in aid process instead of focusing on arts and cultural events.

The grant in aid committee reviewed the applications, interrogated the information submitted and concluded on recommended that and award be made as per the minutes of the grant in aid committee attached herewith as per Annexure "A"

#### FINANCIAL IMPLICATION

As per the award proposed R244,000 from the grants in aid vote.

#### **Declaration of Interest:**

All present declared that they had no personal interest in the agenda items and no personal interest in any of the organisations considered for Grants in Aid as per the Excel spreadsheet that was discussed.

#### **Meeting procedure**

The ACFO lead the meeting in accordance with provisions of the grant in aid policy and explained the process in respect of the consideration of the grants to all present. The only item for consideration is the grant in aid advertised to deliver arts and culture related services to the communities in Bitou Municipality.

4.1.	Grant in aid policy: The Chairperson gave a brief overview of the grant in aid policy and discussed the grant in aid policy requirements for the allocations of grants with the members of the committee.					
4.2.	Principles and requirements in respect of the allocation of grants in aid: The ACFO highlighted the process to be followed, the criteria as per the policy as well as the levels of authority and oversight in respect of the allocation of grants in aid in accordance with Section 67 of the MFMA as well as the municipal grant in aid policy requirements.					
4.3.	Budget available for grants allocation: A discussion was held in respect of the amount that is available, the limitation of funding, it was emphasised that only R250,000 is available for distribution to qualifying NGO/NPO's for the remainder of the 2024/2025 financial year.					
4.4.	Consideration of the matter at hand and evaluation of applications submitted:  The matter considered was the advertisement that was placed for the provision of Arts and Cultural events to Bitou Municipality, which closed on the 13 <sup>th</sup> of March 2025 wherein NPO's were invited to submit funding requests or proposals to provide arts and cultural events to the residents of Bitou Municipality.  Upon closure of the advertisement, 15 applications were received from various applicants.  The members went through the list of applications as well as the Excell schedule that was provided one by one to satisfy themselves that the conditions were indeed met by prospective grant recipients.  A discussion was held, and it was found that in most instances the applicants applied for general grant in aid assistance instead of what was advertised, specifically being Arts and Culture matters.					
	The only application received that sufficiently covered arts and culture events was the application from CT Arts Fest NPC, a non-profit organisation with NPO reference number 2021/620395/08, specialising in arts and culture events.  After deliberation, there was consensus amongst the members that only the one applicant that complied with both the policy as well as the advertisement requirements could be recommended to render the required service to the municipality.
